#### **Fund objective**

To provide a total return, before costs and tax, higher than the S&P/NZX 50 Index (gross and including imputation credits) over the long term (3 years plus).

### Fund update

Stock selection within the financials space contributed positively to performance over the period; notably an underweight to Heartland Group, which fell more than 14.0% for the month. Stock selection amongst utilities also added value in October, including a material overweight to Contact Energy and an underweight to Vector. Stock selection within the communication services space added further value over the period; notably an overweight to Spark New Zealand. Partly offsetting this was our broader underweight to the sector. In contrast, stock selection amongst healthcare names detracted from overall performance. This included an overweight to Ryman Healthcare and an underweight to EBOS Group.

The Carbon Footprint is the Weighted Average Carbon Intensity which we define as relative carbon emissions as the weighted average of portfolio companies' Scope 1 & 2 GHG emissions divided by revenue (CO2e/\$1M revenue USD). Tobacco exposure is defined as the weight of securities in the portfolio classified as being in the GICS tobacco subindustry.
